Ring 1 - Nested Agility courses

Combined levels: Beginners & Novice followed by Senior & Champ
All heights (small to tall)

Ring 2 – Nested Speed Stakes courses (fun flowing jumps & tunnels)

Combined Levels: Beginners & Novice followed by Senior & Champ
All heights (tall to small)

(possible Power & Speed Class if time & interest permits)

Check out the differences & get a chance to give feedback on the UKI rules. Discounted UKI registration will be offered at the match and you can get measured if you register then.

Maximum 80 seconds for agility course, 60 seconds Speed Stakes. This match is to prepare both handler and dog for actual trialing or to give the experienced handler and dog an opportunity to practice in a trial setting.

Rewarding your dog in the ring is encouraged!!! Jump heights are at your discretion. We do ask that your dog have sufficient agility experience and be able to use the equipment safely **off leash**. No physical corrections or harsh verbal corrections allowed. No prong or choke collars allowed. **ABSOLUTELY NO AGGRESSIVE DOGS ALLOWED.**

There will be coffee, tea, hot chocolate available in the morning. Please bring your own lunch. There are several fast food restaurants, Starbucks, etc less than a mile away.

Directions to Nunes Agility Field

Take HWY 99 to Turlock. From south exit Lander and turn right on Glenwood at Chevron Station. From north exit Lander turn left going under freeway and turn right on East Glenwood at Chevron Station. Go left on Golf, it becomes South First Street. The field will be on the left after the veterinary office.

In consideration of acceptance of this entry: Exhibitor/owner certifies that any and every dog they bring to this facility, whether participating or not, is not a hazard to persons, dogs, or property and assume all responsibility, liability and expenses resulting from damages caused by their dog(s). Exhibitor/owner certifies that the entered/training dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the county in which the dog resides. Exhibitor/owner releases John Nunes, Mary Van Wormer/Great Start Agility Training, Veterinary Medical Center of Turlock, Meadows-Quinley Partnership, Hy-Power Hydraulics, Laura Manchester, UK Agility International, Valley Agility Sport Team (VAST) and its Board of Directors and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving your dog, and/or others equipment. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assume sole responsibility for and agree to indemnify and save aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event/training, howsoever such injury or death may be caused and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons. Exhibitor/owner further assumes sole responsibility for any and all damages inflicted upon him/herself, his/her family, friends and dogs.
